115/23 MINUTES OF THE MEETING HELD 11th SEPTEMBER 2023

It was proposed by Cllr D England, seconded by Cllr Parker and **RESOLVED** by all members present, the Minutes of the meeting held on 11th September 2023 be signed as a correct record by the Chairman.

118/23 MATTERS ARISING

The Council considered the following matters arising from the meeting held on 11th September 2023:

- (a) Bridleways:- Further to Minute no. 30/23 (a) the Clerk advised that there were no updates and requested that a meeting with Cllr Potts and Cllr Wilcox was required to understand the history of the issues better.
- (b) Local Highways Improvement Bid:- following minutes no. 95/23(d) the Clerk confirmed that she has received the application paperwork for Ramsey Road and will complete.

- (c) Onyett's Field Byelaws:- Arising from Minutes no. 30/23 (e) the Asst. Clerk updated Members that a public consultation notice had been written and would be going out in the next issue of the Ramsey & Warboys Informer. Advising that the byelaws would be available for viewing in the Warboys Library and at <u>www.warboyspc.org</u>.
- (d) Former Youthie Premises:- Further to minutes 30/23 (g) the Clerk informed members that a site meeting was to be held in the next month with Cambridgeshire County Council (CCC) to discuss the work needed and to determine whether the Parish Council will be able to take over ownership. In addition she would like to include Ben & Co, the new parish centre appointed contractors, as part of the talks.

Members were in full agreement for the Clerk to continue the conversations with CCC and include Ben &Co in those discussions.

(e) Landfill Liaison Meeting:- Cllrs J Parker, D England and J Land were in attendance of the meeting on 3rd October. Cllr D England provided an update for Members on the progress for full closure of the site in approximately 6- 12 months time. As well as informing Members that they will be able to go on a walk round to confirm the that the site has been left in a satisfactory state.

122/23 CLIMATE AND ENVIRONMENT GROUP

Cllr C Sproats provided an update on progress within the committee; this included a potential pilot scheme for collection of small electrical items such as wires for recycling. Members were all in agreement for Cllr Sproats to explore further. She also informed members that the biodiversity report for Onyett's field was back and a meeting would be held to discuss the results with the Biodiversity group.

- Cllr C Sproats to find out more information regarding the pilot scheme and report back to members.
- Cllr C Sproats to set a meeting up with Biodiversity subcommittee to review the Onyett field report.

123/23 PARISH CENTRE

The Parish Clerk updated members on the conditions of the current Parish Centre, making them aware of issues and limitations with the extremely old heating system and the potential that the centre may have to close over the winter.

The Clerk also advised Members that the current heating system required for it to be manually turned on and off each day. She raised the suggestion of a rota to be established, whilst Members agreed to this, there were no volunteers at this time.
