The County Council had invited the Parish Council's comments and while expressing frustration at yet another request for an extension of time, Members were concerned that no penalties can be issued for the further extension in time making it an increasingly lengthy process. Discussions were also had on whether to reestablish the Landfill Liaison Committee. It was determined that they approved the application.
